# Commercial *Entervan*<sup>®</sup> Features

The Braun Commercial Entervan<sup>®</sup> is the culmination of nearly thirty years experience in building personal mobility products. Style, performance, convenience and safety have been aesthetically blended to achieve a new level of refinement in a wheelchair-accessible minivan.

The most striking feature is its handsomely finished automotive look. Easy access to the vehicle is achieved with a lowered floor and low angle ramp. Both the passenger side and the driver side sliding doors have been lowered to match the low floor level with no sill or other obstructions to step over. This standard feature also allows for a better wheelchair turning radius, making it easier to maneuver while inside the vehicle.

The Commercial Entervan<sup>®</sup> comes standard with a removable front driver and passenger seat, and a wheelchair securement position in the front passenger area. This allows a passenger to ride in the front passenger seat or, by simply removing the seat, to ride in their wheelchair.

Safety has always been a top priority at Braun. The Commercial Entervan<sup>®</sup> has been crash tested and certified to meet or exceed all applicable requirements of the Federal Motor Vehicle Safety Standards (FMVSS) and is backed by our three-year limited warranty.

### ◀ Manual Door

ADA-compliant manual driver and passenger sliding door with 56-1/4" vertical opening. Passenger opening is 31 1/2" wide.



### ◀ Manual Ramp

The low-angle 30" wide aluminum foldout ramp makes it easy to load and unload wheelchair users.

### Swing-Out Ramp

The swing-out ramp feature allows ambulatory passengers to exit directly to curbs and sidewalks, away from the flow of traffic.

### Lowered Floor

Up to 16" lower than conventional minivans, the floor is lowered from the toe pan to the rear axle and provides multiple wheelchair securement positions. Premium vinyl flooring with 3/8" marine grade plywood underlayment comes standard.



### ◀ "Step & Roll" Front Passenger Seats

The driver and passenger seats can be easily removed to provide wheelchair securement positions in the front of the vehicle.

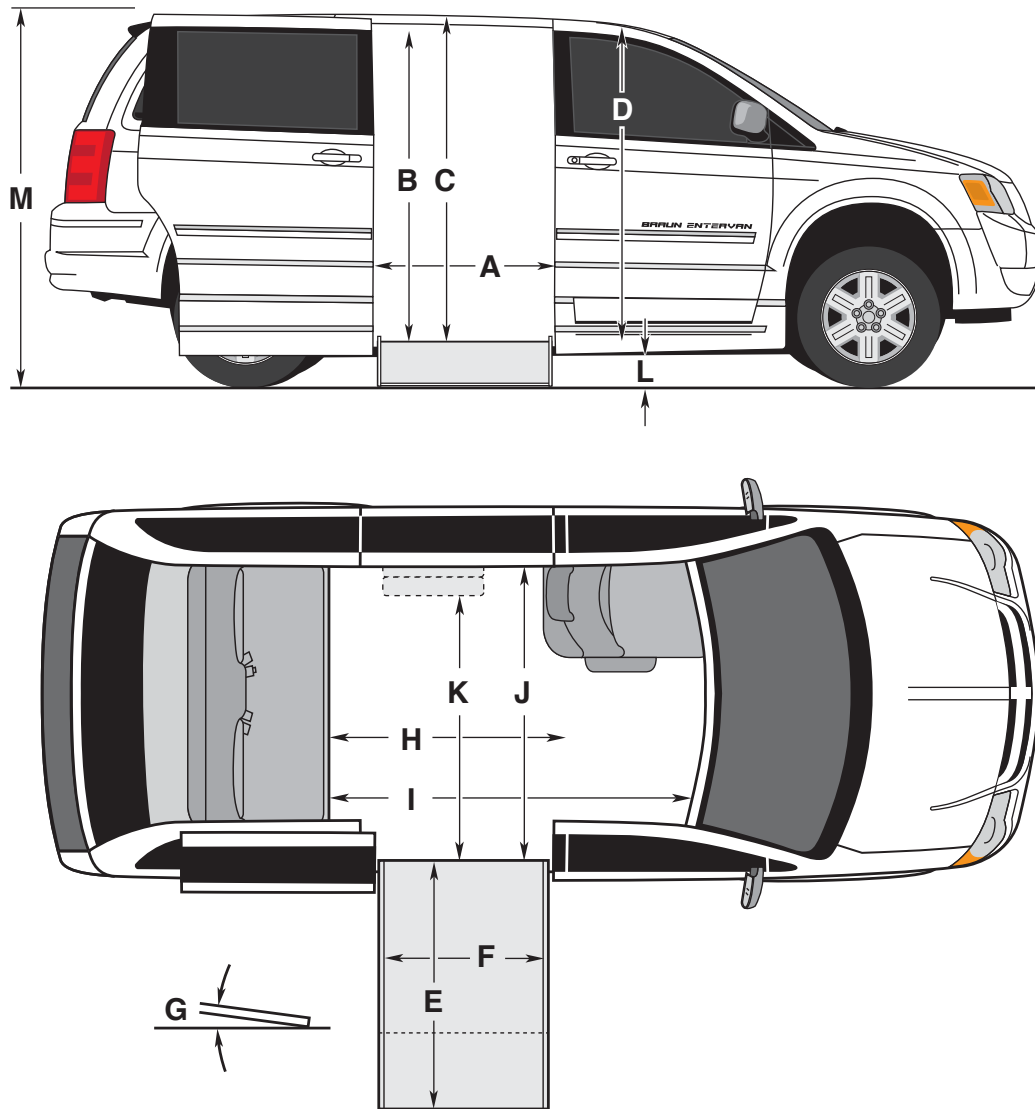


### ◀ Wheelchair/Occupant Securement System

# Chassis Information

**Chassis must be equipped with OEM manual door (non-power).**

**Chassis must not have power folding rear seat.**

**Chassis must be equipped with OEM Load Leveling Suspension (SER) (can be added - see pricing).**

**Chassis equipped with Swivel n' Go Seating require new seat belts for center row positions (see pricing). The Swivel n' Go Seating feature is not retained in the conversion.**

**Before ordering or drop-shipping a chassis, we strongly recommend contacting The Braun Corporation for guidance in deriving payload capacities and selecting equipment and seating options before you purchase the chassis.**

**The Braun Corporation will only convert 2008-2010 chassis with 30,000 or less miles. Chassis must be in sound condition and must never have been involved in an accident. All chassis are inspected and subject to acceptance/rejection upon arrival at the Braun facility.**
